

Wedding Photography Agreement

This agreement is between **Andreo Jab Buhay of Life In Vegas Photography** henceforth referred to as PHOTOGRAPHER, and _____ (bride) and _____(groom), collectively referred to as the BRIDE AND GROOM, for the purpose of providing photography services at the following dates, times, and locations:

1. Pre-wedding photography – specify date, time, and location
2. Wedding ceremony – specify date, time, and location
3. Reception – specify date, time, and location

This agreement supersedes any prior oral and written agreements and there are no other agreements that exist between the two parties. The Photographer and the Bride and Groom shall cooperate in order to fulfill the specified terms and conditions of this agreement.

Terms and Conditions

A. Scope of Work

The Photographer and the Bride and Groom agree that the photography services provided on the specified dates and locations will consist of the following:

1. List here the shots to be made, i.e. bride's clothes, group shots
2. Include the number of pictures
3. Give details of packages
 - photo book, a CD of the pictures, physical prints, and posters

The Photographer agrees to deliver the above images and products no later than _____ days after the wedding date. The Photographer also reserves the right to digitally enhance and manipulate the photos for aesthetic purposes.

B. Fees and Expenses

The total fee for the described photography services is (see attached for pricing) – _____. The Bride and Groom agree to give a partial payment of _____ no later than _____ days before the wedding date. This payment is non-refundable in the event of cancellation of the wedding or of the photography services. The failure to pay this amount on the agreed date will make this agreement null and void.

The Bride and Groom also agree to pay the remaining balance of _____ plus other additional expenses described below no later than _____ days after the wedding date. Should the Bride and Groom choose to pay the total fee before the wedding date and the wedding is cancelled, the Photographer agrees to return the amount of _____.

The additional expenses incurred will consist of the following:

1. Food, beverage, and accommodation costs for the Photographer, not exceeding _____ (specify amount agreed on).
2. Car service for the photographer, not exceeding _____ (specify amount agreed on).

The Bride and Groom agree to use any of the following methods of remuneration:

1. Cash
2. Cashier's check
3. Bank deposit

C. Copyright and Model Release

The prints and the accompanying CDs will become the property of the Bride and Groom. These can be reproduced for personal use, for personal websites, and for dispersal to family and friends as long as the Photographer is acknowledged.

The Bride and Groom allow the Photographer and his/her assigns to legally exhibit the wedding images in portfolios, websites, and competitions, as long as the Bride and Groom are presented in a positive light.

D. Cooperation

The Bride and Groom agree to conduct a pre-event consultation with the Photographer to finalize the schedules, times, and locations of the wedding. This consultation will also discuss any changes and extensions of the photography services. During the consultation, the Bride and Groom will designate a person who will be the Photographer's guide in identifying people who are included in the previously listed shots.

The Bride and Groom agree to provide sufficient time (approximately 30 minutes) before and after the wedding ceremony to allow the Photographer to take the photographs specified in the list. The Photographer is not responsible for missing images due to the absence of persons who should be included in such shots or due to the failure of identifying such persons.

The Bride and Groom agree that Jab Andreo Buhay of Life In Vegas Photography is the sole Photographer of the event. Wedding guests who are also taking pictures will be requested to cooperate with the Photographer. The Photographer agrees to take additional images only at the direct request of the Bride and Groom.

E. Limit of Liability

In the unlikely event that the Photographer is injured or too ill to photograph the wedding and there is no suitable replacement, the Photographer will refund ALL payments received for the agreed photography services.
